

SCRIP REBATE DESIGNATION FORM 2020– 2021
St. John Vianney

By voluntarily participating in SJV’s SCRIP fundraiser during the 2020 – 2021 school year, you have the opportunity to earn a credit towards your family’s school tuition for next year or a reimbursement of a portion of your current year’s Christian Formation fees. You may retain the credit for yourself or assign it to a family which you designate. You may also take a cash rebate.

Under this program, 50% of the profits or rebates will go to the SJV’s Home & School general revenue fund to cover the administration of the plan. Each participant has three options available to them for the remaining 50% of the profits:

Option 1 - Tuition Credit/CF Fees: Participants will receive tuition credit equal to 50% of the profit raised as a result of their purchases through SJV’s SCRIP program. Participants can choose to retain the benefit for their own family or assign it to a family with student(s) enrolled in either SJV’s school or Christian Formation program. The family to whom the participant chooses to assign the benefit is termed the “designated family.”

- If a designated family has student(s) enrolled in SJV’s school during the 2020 – 2021 school year, the benefit will be awarded as a credit to the designated family’s tuition obligation for the 2021 – 2022 school year.
- If a designated family has student(s) enrolled in SJV’s Christian Formation program during the 2020–2021 school year, the benefit will be awarded by check to the designated family at the end of the 2020–2021 school year.

Option 2 – SJV Donation: 100% of the profit earned as a result of the participant’s purchases through SJV’s SCRIP program remains within SJV. 50% will go directly to the general revenue fund of Home & School Association. The participant then assigns the remaining 50% to either SJV’s Home & School General Fund or to the SJV parish general stewardship fund.

Option 3 – Cash Rebate: Participants may receive 50% of the profits raised as a result of their purchases through SJV’s SCRIP program as a cash rebate. The cash rebate will be sent to the participant after the end of the 2020 – 2021 school year. *If the portion of the profit is below \$10, a check will not be generated unless specifically requested.*

In order to communicate your chosen option, please complete the bottom portion of this form and return it to the SJV school office or parish office. If you do not return a completed designation form, 100% of the profits will be retained by the SJV Home & School Association. **Please return to school office by September 8, 2020.**
